

SAFARI MONTAGE® LIVE! SOFTWARE LICENSE AGREEMENT

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT CAREFULLY. BY USING THE SAFARI MONTAGE LIVE! SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. AS A RESULT, IF YOU DO NOT AGREE WITH ANY OF THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT USE THE SAFARI MONTAGE LIVE! SOFTWARE.

THIS IS A LICENSE, NOT A SALE. ALL SAFARI MONTAGE SOFTWARE PRODUCTS ARE LICENSED ON THE TERMS AND CONDITIONS SET FORTH IN THIS SOFTWARE LICENSE AGREEMENT THAT, AMONG OTHER THINGS, DEFINE WHAT THE LICENSEE MAY AND MAY NOT DO WITH ANY SAFARI MONTAGE LIVE! SOFTWARE AND CONTAINS LIMITATIONS ON DAMAGES, WARRANTIES AND/OR REMEDIES.

1. Definitions.

- 1.1. "SAFARI Montage" means Library Video Company and its trade names, divisions, subsidiaries, successors, assigns and affiliates, if any.
- 1.2. "Software" means the SAFARI Montage Live! web-conferencing solution, including the software and related documentation, instructions, and written materials.

2. Licensee: Administrator; End Users and Authorized Representative.

- 2.1. "Licensee" means the purchaser of the software license, which may include, without limitation, schools, school districts, regional media centers or like institutions. Licensee shall cause the Administrators and other End Users to comply with the terms of this Software License Agreement by implementing and distributing all necessary policies and notices and/or requiring Administrators and other End Users to agree to the terms of this Software License Agreement. Licensee is responsible and liable for compliance with the terms and conditions of this Software License Agreement and for any breach hereof.
- 2.2. "Administrator(s)" means End Users responsible for managing, coordinating and reporting on the Software functions, which may include, without limitation, librarians, information technology specialists, educators and other computer professionals and who are employed or contracted by Licensee. The Administrator shall also develop and implement plans to maintain security, restrict access to the Software, and protect the data and personal information of End Users.
- 2.3. "End User(s)" means each individual person who Licensee authorizes to use the Software functions, which may include, without limitation, Administrators, students, teachers, tutors, instructors, home school parents and educators.

3. Software License. SAFARI Montage hereby grants to Licensee, subject to the terms of this Software License Agreement, a non-transferable, non-exclusive license:

- 3.1. to use the Software, in object code format only, solely for Licensee's non-commercial, internal purposes for the direct benefit of Licensee;
- 3.2. to provide access to the Software and control of Software functions to the Administrator(s) to use expressly as set forth in an administrator's guide as supplied by SAFARI Montage; and
- 3.3. to provide access to the Software functions to the End Users to use expressly as set forth in a user guide supplied by SAFARI Montage.

4. License Restrictions. The software license is subject to the express restrictions set forth below. Licensee shall not, and shall not allow or authorize any Administrator, End User(s) or other third party to:

- 4.1. modify or create any derivative work of the Software or adapt, translate, reproduce or convert all or any part of the Software;
- 4.2. reverse engineer, decompile or disassemble the Software or otherwise attempt to access the source code or method of operation;
- 4.3. sell, license, sublicense, distribute, lease, rent, export, loan or otherwise transfer the Software to any third party or to provide a service bureau or to become an application service provider and allow third parties to access the Software;
- 4.4. assign this Software License Agreement to any third party (and any attempt to do so shall be void);
- 4.5. alter, obscure or remove any copyright, patent, trademark or other proprietary or legal notice on or in the Software;
- 4.6. use the Software to infringe the intellectual property rights, the proprietary rights or the rights of publicity or privacy of any third party; or disseminate, publish or distribute information or materials in any form Licensee knows or should know is harmful, threatening, abusive, harassing, tortious, defamatory, vulgar, obscene, libelous or otherwise objectionable under applicable community standards;
- 4.7. separate the component parts of the Software or separate the Software from the hardware on which the Software is installed, as the SAFARI Montage Live! product is licensed as a single product; or
- 4.8. ship, transfer or export the Software into any country or use the Software in any manner that is prohibited by the United States Export Administration Act or by any other export laws, restrictions or regulations of the United States, Canada or any other jurisdiction as the Software may be subject to U.S. export control laws or other governmental export and import laws and regulations.

5. Third Party Software.

5.1 The Software may contain or include third party software that requires Licensee compliance with additional license terms and conditions. If any portion of the Software is governed by a separate license agreement between Licensee and a third party, Licensee agrees that for any such third party software (a) the terms of such separate license agreement (including its warranties, restrictions and remedies, if any) shall apply to that software and are hereby incorporated by reference into this Software License Agreement, and (b) in the case of any software licensed under an open source license agreement, nothing in this Agreement shall be read to add additional conditions or restrictions, or affect any rights and/or obligations Licensee may have, pursuant to any such open source license. Certain third party software may require Licensee registration as a condition prior to Software shipment. Where necessary, Licensee authorizes SAFARI Montage to register for and accept such third party licenses on its behalf prior to Software delivery.

5.2 Without limiting the generality of Section 5.1, the Software requires Adobe Media Server software (the "Adobe MS") to function properly, and Licensee hereby acknowledges that Adobe MS is a third-party software product. SAFARI Montage has a license to supply Adobe MS to qualified end users, and such software is being licensed, not sold, to Licensee. Adobe MS is subject to an Adobe end user license agreement (the "Adobe EULA"), which Licensee must accept prior to using the software. Adobe MS is subject to any warranty contained within the Adobe EULA and/or to such other warranties as Adobe may make available from time to time to cover Adobe MS, and no SAFARI Montage warranty shall apply. Licensee hereby acknowledges that in licensing Adobe MS to Licensee, SAFARI Montage as reseller is subject to certain Adobe-imposed restrictions and obligations, including, in relevant part: (1) territorial distribution restrictions, which generally prohibit distribution of the Adobe MS software outside of the continental United States; (2) restrictions against dealing in illegal, gray market or

unauthorized copies of the Adobe MS software; (3) restrictions on the end users to whom special-version Adobe MS software may be licensed; and (4) an obligation to report to Adobe any occurrence of any of the restricted activities set forth above, whether carried out by SAFARI Montage, by Licensee or by others. Please note in addition that if the Adobe MS version being licensed to you is designated as an education or government version, it may only be provided to qualified educational establishments or government entities, respectively. While SAFARI Montage is responsible for verifying Licensee's status as a qualified purchaser of Adobe MS software that is restricted for distribution to particular market segments or end users, Licensee agrees to promptly provide any information upon request if needed to confirm Licensee's eligibility. Licensee hereby represents and warrants that any such information provided by Licensee in response to a SAFARI Montage request shall be truthful, complete and accurate, and Licensee agrees to indemnify and hold SAFARI Montage harmless from and against any claims, losses or liabilities arising from Licensee's breach of the foregoing warranty and/or Licensee's failure to cooperate with SAFARI Montage as required under this Section 5.2.

6. Use of Information and Materials With the Software. In accordance with section 4.6, Licensee is, and shall remain, solely responsible for all information or materials in any form that Licensee (either directly or by an Administrator or other End User) uploads, posts, distributes, transmits or otherwise disseminates through, or in connection with, the Software. Licensee represents and warrants that Licensee is the owner or authorized user of all such materials or has obtained all necessary permissions and licenses to such materials.

7. License Duration; Audit and Termination.

7.1. Duration. The grant of license provided in this Software License Agreement is perpetual; provided, however, SAFARI Montage may terminate this Software License Agreement if Licensee fails to comply with any of the terms and conditions herein and/or fails to timely pay all associated license fees. Further, Licensee recognizes, agrees and understands that SAFARI Montage does not represent and warrant that the Software will function in any specific manner for the duration of the license and further that SAFARI Montage will provide technical support only for the current and preceding version of the Software during the period under which the Software is covered by the SAFARI Montage Software Limited Warranty or the SAFARI Montage Software Update Plan, and in accordance with (and only to the extent required by) the specific terms of each.

7.2. Audit Rights. Licensee acknowledges and agrees to: (a) fully document and certify that use of the Software conforms to the license within twenty (20) days of SAFARI Montage's request for such documentation and certification; and/or (b) permit SAFARI Montage to audit the use of the Software in such reasonable manner as SAFARI Montage may consider appropriate. In the event any such documentation or audit demonstrates that Licensee is in breach of any provision of this Agreement, any Licensee fails to remedy the breach to the satisfaction of SAFARI Montage within five (5) business days of notice thereof, SAFARI Montage shall determine, in its sole discretion, the appropriate remedial action, which may include any or all of the following: (a) termination of the Agreement; (b) Licensee's payment of license fees; and/or (c) Licensee's modification or change to software usage to correct the deficiency and resolve the breach.

7.3. Automatic Termination. Notwithstanding anything in Section 7.1 to the contrary, this Software License Agreement shall terminate immediately upon the breach of Sections 3 or 4, unless SAFARI Montage assents in writing to continue this Software License Agreement.

7.4. Upon Termination. In the event of any termination of this Software License Agreement, Licensee must immediately cease use of the Software and return to SAFARI Montage or, upon request, destroy all copies of the Software and all of its component parts and certify such destruction to SAFARI Montage in writing. Sections 1, 6, 7, 9, 10, 11 and 13 shall survive any termination of this Software License Agreement.

8. Warranty; Remedies.

8.1. Limited Warranty. SAFARI Montage's warranty obligations are limited to the terms set forth in the version of the SAFARI Montage Hardware and Software Limited Warranty (the "Limited Warranty") in effect as of the time of Licensee's first acceptance of this Software License Agreement.

8.2. Remedies. SAFARI Montage's entire liability and Licensee's sole and exclusive remedy for any breach of the foregoing limited warranty will be, at SAFARI Montage's option, repair or replacement of the Software as detailed more fully in the SAFARI Montage Hardware and Software Limited Warranty.

9. Exclusion of Damages, Limitation of Liability and Disclaimers.

9.1. NEITHER SAFARI MONTAGE NOR ANY ITS AFFILIATES, SUBSIDIARIES, DIVISIONS, EMPLOYEES, CONTRACTORS, AGENTS, SUCCESSORS, ASSIGNS, SUPPLIERS OR MANUFACTURERS SHALL BE LIABLE, REGARDLESS OF CIRCUMSTANCES AND REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT OR IN TORT, FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL, PUNITIVE OR EXEMPLARY LOSSES OR DAMAGES OF ANY NATURE OR KIND WHATSOEVER DIRECTLY OR INDIRECTLY ARISING FROM THIS SOFTWARE LICENSE AGREEMENT, INCLUDING, BUT NOT LIMITED TO, LOSSES OR DAMAGES ARISING OUT OF OR RESULTING FROM ANY USE, ACCESS TO OR FAILURE OF THE SOFTWARE OR HARDWARE, LICENSEE'S INABILITY TO USE THE HARDWARE OR SOFTWARE (EITHER SEPARATELY OR IN COMBINATION WITH ANY OTHER HARDWARE OR SOFTWARE), LOST OR CORRUPTED CUSTOMER, THIRD PARTY OR OTHER INFORMATION, DATA OR FILES, LOST PROFITS OR LOST GOODWILL, FAILURE TO REALIZE SAVINGS, PROPERTY DAMAGE, INTERRUPTIONS IN THE LICENSEE'S USE OF OR ACCESS TO ANY HARDWARE, SOFTWARE OR OTHER PRODUCT OR SERVICE, OR FOR ANY CLAIM OR DEMAND AGAINST THE LICENSEE BY ANY THIRD PARTY, EVEN IF SAFARI MONTAGE HAS BEEN ADVISED OF THE POSSIBILITY OF ANY OF THE FOREGOING LOSSES OR DAMAGES. NEITHER SAFARI MONTAGE NOR ANY OF ITS AFFILIATES, SUBSIDIARIES, DIVISIONS, EMPLOYEES, CONTRACTORS, AGENTS, SUCCESSORS, ASSIGNS, SUPPLIERS OR MANUFACTURERS SHALL BE LIABLE FOR ANY DAMAGE TO OR LOSS OF ANY PROGRAMS, DATA OR OTHER INFORMATION STORED ON ANY MEDIA, OR ANY NON-SAFARI MONTAGE-BRANDED PRODUCT OR PART NOT COVERED BY THIS SOFTWARE LICENSE AGREEMENT. THE MAXIMUM AGGREGATE LIABILITY OF SAFARI MONTAGE FOR EACH AND ALL CLAIMS ARISING UNDER OR RELATING TO THIS SOFTWARE LICENSE AGREEMENT OR ITS SUBJECT MATTER SHALL NOT EXCEED THE AMOUNTS THAT MUST BE PAID BY LICENSEE TO SAFARI MONTAGE FOR USE OF THE SOFTWARE DURING THE 12 MONTHS BEFORE THE INITIAL CLAIM ARISING UNDER OR RELATING TO THIS SOFTWARE LICENSE AGREEMENT.

9.2 OTHER THAN THE EXPRESS WARRANTIES SET FORTH IN THIS SOFTWARE LICENSE AGREEMENT, SAFARI MONTAGE HEREBY EXPRESSLY EXCLUDES AND DISCLAIMS ALL IMPLIED AND EXPRESS WARRANTIES, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. UNDER THIS SOFTWARE LICENSE AGREEMENT, SAFARI MONTAGE DOES NOT GUARANTEE OR WARRANT THAT: (A) ANY HARDWARE OR SOFTWARE WILL MEET THE LICENSEE'S REQUIREMENTS OR THAT THE OPERATION OF ANY HARDWARE OR SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE; OR THAT (B) ANY HARDWARE OR SOFTWARE WILL BE COMPATIBLE WITH ANY OTHER CONTENT, PRODUCT OR SYSTEMS. THE LICENSEE ASSUMES RESPONSIBILITY FOR THE SELECTION OF ANY HARDWARE AND SOFTWARE TO ACHIEVE THE LICENSEE'S INTENDED RESULTS, AND FOR THE USE AND RESULTS OBTAINED FROM ANY HARDWARE AND SOFTWARE. EXCEPT FOR THE LIMITED WARRANTY REFERENCED IN SECTION 8.1 ABOVE, THE SOFTWARE IS PROVIDED AS-IS TO LICENSEE.

10. Ownership and Copyright. SAFARI Montage is the owner, or licensee, of all intellectual property rights in and to the Software and all derivative works thereof, including, without limitation all copyrights, trade secrets, and trademarks. Licensee shall have no right, title or interest

in or to the Software except in accordance with the license grant. SAFARI Montage has, and retains the right to, modify or remove any feature or functionality of the Software at any time, including correcting any intellectual property or legal issues.

11. **Indemnity.** Licensee shall indemnify and save harmless, to the extent permitted by state statute, SAFARI Montage from and against any and all losses, damages, expenses or claims of any nature, whatsoever, SAFARI Montage may suffer or incur as a result of any breach by Licensee of any provision of this Software License Agreement. This provision shall survive the termination of this Software License Agreement for any reason.

12. **Infringement Indemnity.** SAFARI Montage shall indemnify, defend or, at its option, settle any claim or suit against Licensee arising from a claim that the Software infringes any patent, trademark, copyright or trade secret, and SAFARI Montage shall pay any final judgment entered against Licensee in any such proceeding; provided SAFARI Montage has sole control of such defense and/or settlement, and Licensee promptly notifies SAFARI Montage and provides SAFARI Montage with reasonable assistance. If any part of the Software is, or becomes, the subject of any such proceeding (or is adjudicated to infringe), SAFARI Montage may, at its expense and option, do one of the following things: (i) procure for Licensee the right to continue to use the Software; (ii) replace the Software with other suitable software or programs; (iii) modify the Software to make it non-infringing; or (iv) if none of the foregoing are commercially reasonable, terminate the Software license and refund the payments paid by Licensee for the Software or the affected part(s) thereof, less reasonable amortization for use. SAFARI Montage shall have no obligations under this section with respect to any claim to the extent it is based upon the combination, operation or use of the Software with software or hardware other than as specified by SAFARI Montage, if such infringement would have been avoided in the absence of such combination, operation or use. This infringement indemnity does not apply to any third party manufactured products.

13. Miscellaneous Provisions

13.1. **Entire Agreement.** This Software License Agreement constitutes the entire agreement and understanding between Licensee and SAFARI Montage pertaining to the matters set forth herein. This Software License Agreement supersedes all prior or collateral oral or written representations, discussions, communications, advertising or agreements related to the subject matter set forth herein, and SAFARI Montage is not bound by any representation or inducement not specifically set forth herein.

13.2. **Severability.** Each and every provision of this Software License Agreement is severable. If a court of competent jurisdiction declares any provision hereof to be void or unenforceable, then the same shall be struck from this Software License Agreement without in any way affecting the validity of any other provision of this Software License Agreement. This Software License Agreement will be deemed amended to the extent necessary to make it enforceable and valid, and the remaining terms and provisions will remain in full force and effect.

13.3. **Modification.** This Software License Agreement may not be modified or amended except in writing signed by an authorized representative of SAFARI Montage. No other SAFARI Montage employee is authorized to modify this Warranty Agreement or to make any representations or agreements, written or oral, concerning the subject matter herein, and no such modification, representation or agreement shall be binding upon SAFARI Montage.

13.4. **Force Majeure.** SAFARI Montage shall not be liable in any way under this Software License Agreement as a result of SAFARI Montage or its agents, employees or contractors being delayed, prevented or hindered in the performance of SAFARI Montage's obligations under this Warranty Agreement by reason of any circumstances beyond its reasonable control, including, without limitation, fire, flood, power surges, civil disorder, government actions, war, terrorism, import or export regulations or embargoes, labor disputes, strikes, supply disruptions and/or acts of God, including, without limitation, lightning and earthquakes.

13.5. **Non-Transferable, Waiver and Notice.** This Software License Agreement is non-transferable and may not be assigned or delegated by Licensee without the prior written approval of SAFARI Montage, and any attempt to assign or delegate this Software License Agreement without such approval shall be deemed null and void. SAFARI Montage's failure to exercise any rights herein shall not constitute or be deemed a waiver or forfeiture of such rights, and to be effective, any waiver by SAFARI Montage of (i) any provision of this Software License Agreement, (ii) any breach by Licensee, or (iii) any of SAFARI Montage's rights hereunder must be in writing signed by a duly authorized representative of SAFARI Montage. Any waiver by SAFARI Montage shall not operate or be construed as a waiver by SAFARI Montage of any other right hereunder. SAFARI Montage may assign or delegate this Software License Agreement to an affiliate, to a successor-in-interest, or to any third party in its sole discretion. Any notices required to be given hereunder shall be given in writing and addressed as follows: if to Licensee, to the address or email address of Licensee on file with SAFARI Montage; and if to SAFARI Montage, to the General Counsel at SAFARI Montage's corporate headquarters

13.6. **Subcontracting.** SAFARI Montage may subcontract or delegate any of its obligations under this Warranty Agreement to any third party in its sole discretion.

13.7. **Governing Law; Venue.** This Software License Agreement shall be enforced and interpreted subject to the laws of the Commonwealth of Pennsylvania, without regard to any conflict of law principles. Any claims arising under this Warranty Agreement shall be exclusively brought and litigated in the state and federal courts in and for Montgomery County, Pennsylvania, and Licensee hereby consents to the exclusive jurisdiction of such courts.
